Data Protection Legislation

The General Data Protection Regulation (GDPR) came into force in May 2018. It places obligations on us as a company to protect your data, making us more accountable and transparent for how we keep and use your personal information.

What GDPR means to you

You now have more control over your own personal information and how companies, like Dealer Net Finance, hold your information.

You can find out more about how we handle your personal information.

You now have the 'Right To Be Forgotten', which means you can ask us to delete or remove your personal information we have on record if there is no compelling reason for us to keep it.

We will only process your personal information if we have a lawful basis for doing so --

For example – Managing your financial agreement(s) with different funders, as a result of a legal obligation or your consent.

Our Privacy Information Notice -

Personal information which you provide Dealer Net Finance with may be used for our business purposes such as:

- To prepare proposals & paperwork for your finance application
- To keep records of your requirements
- To contact you in regards to your application & agreements
- For accounting & regulatory purposes
- To Keep you informed and up to date on our services

We may share information we have for you with other firms including finance companies as part of your finance application. If you take out an agreement through our services, we will keep your data for ten years after the end of your contract. If you do not take out an agreement through Dealer Net Finance, we will keep your data for three years.
